
#### PHIP Alzheimer's Walk-2023

## Treatment Update and why we walk and have been doing for so many years.

The Alzheimer's Association has long been the leading voice on behalf of people living with this fatal disease. The Association believes that these people deserve the opportunity to discuss and choose, with their doctors and family, whether an approved treatment is right for them. This discussion should take place with as few

treatment of early Alzheimer's disease. This is the first traditional approval of an Alzheimer's treatment that changes the underlying course of the disease.

Today, we are living history: the U.S. Food and Drug Administration (FDA) granted traditional approval of lecanemab, sold under the brand name Leqembi, for the treatment of early-stage Alzheimer's disease. In addition, the Centers for Medicare & Medicaid Services (CMS) announced it will cover the treatment through Medicare.

However, the drug has not been widely used because it costs \$26,500 annually before insurance coverage. Now, with the latest approval, the Centers for Medicare and Medicaid Services said it will expand coverage of the drug, broadening access for people with early forms of the disease.

While this is a tremendous step forward, the Alzheimer's Association's work is far from done. We won't rest until everyone living with Alzheimer's — at any stage — can get the treatment, care, and support they need and deserve.

Our efforts (Parrot Head Clubs around the country) have been a huge success. We raised \$162.969.00 total for 2022. (Thank you!) It's been a good year nationally for getting out and "Partying with a Purpose." That was accomplished with 51 teams (clubs) walking.

At his time, we only have 35 teams signed up to walk in 2023. Please go to the Alzheimer's Walk and sign up your club/team to walk to fight this disease.

#### **Nautical Wheelers IT Corner**

News and Updates from the PHIP Communications and Technology Committee

There's been many concerns raised about the type of security and protection safeguards regarding the submission of the club memberships. Although I've tried to keep it simple, it's not easy to explain without getting a little technical.

#### Our PHiP

websites, motm.rocks & phip.com, use Secure Sockets Layer (SSL)/Transport Layer Security (TLS) to protect data transmitted between internet connections. This protocol is a standard technology for keeping an internet connection secure and safeguards data that is being sent between two systems. It achieves this by using encryption algorithms and cryptographic keys to scramble data in order to prevent hackers from reading it as it is sent over the network connection. This assures that any data transferred between users and sites, or between two systems remain impossible to read.

This SSL/TLS protocol is associated with a padlock icon that appears in your browser's address bar whenever you enter a secure website (or access a secure website page). Before entering any personal or financial information online, noticing this padlock icon before entering any data provides an assurance that any information will be handled in a secure manner. On the other hand, if information is entered on an unsecured website, data would be transmitted from your computer to the web server un-encrypted and viewable in plain text. Anyone 'sniffing' packets (reading data) from the network can capture your information and use it fraudulently. This can be harmful if the data contains usernames, passwords, or personal financial type information. This is one way hackers gather/steal information by nonsuspecting users who often connect to compromising public Wifi services.

### **Nautical Wheelers IT Corner (Cont.)**

In addition to our websites, every on-line application utilized by PHiP (involving registration and data storage) all use the SSL/ TLS protocol. All data collected during registration and uploaded is currently stored in the PHIP Dropbox account. Dropbox is a very secure cloud container (google it for yourself). Dropbox files at rest are encrypted using 256-bit Advanced Encryption Standard. Although this provides more than enough protection for the type of data we are collecting, PHiP adds another layer of protection by encrypting these files a second time. This would help in the event where shared links are inadvertently shared or wrongfully obtained to gain access. With the added encryption, having access or copies of these files would be useless without the specific decryption key.

While the information collected by PHiP can be considered "personal Information" (i.e. address/email phone number, ...), this data is readily available on-line and basically in the public domain. No different than the telephone books of the past (that you still might have laying around). That said, even though this information may be available in the public domain – it doesn't mean that it's necessarily "publicly available information" under some state and country statutes.

I hope this addresses many of the reservations and concerns regarding the handling of club membership information, but let me know if there are still any remaining concerns

And lastly, as a general question, I'd be interested to hear what type of security provisions or guidelines clubs currently have in place to provide the protection to the personal information/identity of their members?

To minimize the bandwidth, please feel free to backchannel me instead of a general reply.

## Atlanta PHC Does Their Charity Fund Raising at Sea You Are Invited to Join Them

During the Atlanta Parrot Head Club's 34th Anniversary Party held on April 29th the club presented \$35,000 in donations to two local charities. These donations represent about half of the \$64,700 raised during the club's most recent phlocking event, Parrothead Cruise 2023, which ultimately supported four breast cancerrelated organizations. 433 Parrot Heads representing 53 PHiP-chartered clubs sailed with us and were entertained onboard by Barefoot Reggie Starrett, Brent Burns, Drop Dead Dangerous (Kitty Steadman and Melanie Howe), and "Three Boat Drunks" (Mike Miller, Dyke Corson, and Howie Golub). The Anniversary Party itself also raised \$3,500 in support of the St. Croix Animal Welfare Center, which is enough to fully pay for a chartered flight to rehome a planeload of animals as part of their Paws from Paradise program.

The Atlanta Parrot Head Club has already announced our next phlocking, **Parrothead Cruise 2024**: Changes in Latitudes, where we hope to raise even more for charity. We'll change our latitudes when we set sail aboard the Norwegian Escape on Saturday, March 9, 2024, for seven nights, departing from Port Canaveral, Florida. We'll visit Cozumel, Mexico; George Town, Grand Cayman; Ocho Rios, Jamaica; and Great Stirrup Cay, The Bahamas. Entertaining us onboard and in-port will be Scotty Emerick, James "Sunny Jim" White, Eric Erdman, Carrie Welling, and Rum Monday featuring Matt Hall, Quincy Yeates, and Vince Ilagan.
